In consideration of the mutual promises of the parties contained in this Waiver, or of the acts to be performed by either, the parties agree that I hereby knowingly and voluntarily waive any claims, damages or causes of action which I may have or incur against CCI, its officers, directors, agents and affiliates because of my donation of time and effort.
